# MINUTES OF A REGULAR MEETING OF THE BOARD OF ALDERMEN OF THE CITY OF MOUNT VERNON, MISSOURI ON TUESDAY, APRIL 10, 2018.

The Board of Aldermen of the City of Mount Vernon, Missouri met in a regularly scheduled meeting, at the regular place of meeting, City Hall, on Tuesday, April 10, 2018 at 7:00 p.m. The meeting was called to order by Mayor David W. Eden with the following roll call recorded: J.N. Greene, Craig Nelson, Jason Haymes, Lowell Phillips, Sherie Thrasher, Kathy Fairchild, Sandy Martin and Sue Lee. The following city personnel were also in attendance: City Administrator Max Springer, Attorney William Petrus, Jr., Treasurer Shari Weldy, Director of Public Works Gene Stanton, Director of Public Works in training Joe Kelley, Code Enforcement Officer Bruce Conway, Chief of Police David Hubert and City Clerk Shannon Neely. Absent: Fire Chief Brad DeLay.

## Approval of Agenda.

Mayor Eden presented the agenda to the Board for approval. Alderman Phillips made a motion, seconded by Alderwoman Martin to approve the agenda with the following amendment:

• City Administrator Report. Add Discussion of Blight Study (TIF).

With all present members voting in favor, Mayor Eden declared the motion approved.

## Presentation of Minutes.

Mayor Eden presented the minutes from the City Council meeting held on Tuesday, March 27, 2018 to the Board for approval. Alderman Phillips made a motion, seconded by Alderwoman Lee to approve the minutes as presented. With all present members voting in favor, Mayor Eden declared the motion approved.

• Danny Burks discussed unsightly property located on Filmore Street which has several un-tagged cars, golf cart and a large amount of trash. A lengthy discussion was held.

## Presentation of Audit.

Rebecca Friedrich, Senior Auditor with KPM CPAs presented the final audit for the year 2017 to the Board and reported the city has received an "unmodified" opinion on the audit. Discussion was held.

## City Administrator.

Springer held discussion on the following items:

- Sales Tax Revenue. Springer reported sales tax revenue and held discussion.
- 109 N. Hickory Street. Springer noted the Board had previously requested information on equipment at 109 N. Hickory Street and reported the roof, boiler and chiller were installed sometime between 1987 and 1989 during remodeling of the building. Springer reported final closing on the building was held earlier in the day. Discussion was held.
- Fire District. Springer reported he would be meeting with members of the new Fire Board to discuss requirements in formation of the Fire District after the approval at the general election on Tuesday, April 3, 2018. A lengthy discussion was held.
- Blight Analysis Study (TIF). Springer reported Gilmore & Bell received five proposals
  for the Blight Analysis Study required by TIF and presented the bid tab. Discussion was

  project to Development Initiatives to conduct a Blight Analysis Study (TIF). With all

## Treasurer.
